SERVICE AGREEMENT

This Agreement is entered into between R.O.G. SCREENING & SELECTION, LLC and its affiliates and subsidiaries ("R.O.G. SCREENING & SELECTION, LLC"), and the entity first set forth herein ("Subscriber").

1. SERVICE. R.O.G. SCREENING & SELECTION, LLC provides nationwide public record information, document retrieval and related services ("Services") using proprietary databases and information obtained from third parties ("Third Parties"). Subscriber hereby subscribes to Services for use as a factor in making its business decisions and agrees to pay to R.O.G. SCREENING & SELECTION, LLC all applicable rates and charges set forth for use of said services.

2. PERFORMANCE. R.O.G. SCREENING & SELECTION, LLC will use reasonable efforts to deliver Services requested by Subscriber and to access, update, augment and maintain its compilation of information gathered from selected public records and other sources used in the provision of Services hereunder. Subscriber accepts all information "AS IS."

3. SUBSCRIBER CREDENTIALS AND CREDIT REPORT. Subscriber acknowledges and understands that R.O.G. SCREENING & SELECTION, LLC will only allow Subscriber to access the Services if Subscriber's credentials can be verified in accordance with R.O.G. SCREENING & SELECTION, LLC internal credentialing procedures. Subscriber shall notify R.O.G. SCREENING & SELECTION, LLC immediately of any changes to the information on Subscriber's application for Services (including any change of address) and, if at any time Subscriber no longer meets such procedures, R.O.G. 4. CHARGES TO SUBSCRIBER. For each response to a request for information, including "no record found," Subscriber agrees to pay to R.O.G. SCREENING & SELECTION, LLC the applicable charge then prevailing for Services rendered to Subscriber. Subscriber shall pay to R.O.G. Subscriber is responsible for payment of all collection costs and attorney fees incurred by RETAIL OPTIMIZATION GROUP, LLC through its efforts to collect on balance(s) owed by Subscriber. All remittances shall be sent to the "remit to" address on the invoice.

5. OWNERSHIP. Subscriber acknowledges that R.O.G. SCREENING & SELECTION, LLC and/or Third Parties retain all right, title, and interest under applicable contractual, copyright and related laws in the databases and information contained therein and used to provide Services hereunder. Subscriber shall use such information consistent with such right, title and interest and notify R.O.G. SCREENING & SELECTION, LLC of any threatened or actual infringement thereof.

6. SUBSCRIBER USE LIMITATIONS - END USER. Subscriber acknowledges that this Agreement grants Subscriber a limited license in exchange for payment of the fees and charges set forth herein, and Subscriber shall not reproduce, retransmit, republish or otherwise transfer for commercial purpose any information that Subscriber receives from Services, except to employees whose duties reasonably relate to the legitimate business purposes for which the information is requested. Subscriber warrants that it is the end user of the information, and agrees to limit use and dissemination of information from Services solely to the business use(s) stated by Subscriber in the application and online. Subscriber acknowledges that R.O.G. SCREENING & SELECTION, LLC is providing data to support Subscriber's own processes and decisions, and Subscriber should not deny any service or access based solely on data or results provided by R.O.G. 7. SUBSCRIBER USE LIMITATIONS - FAIR CREDIT REPORTING ACT. Subscriber certifies to use any data obtained through R.O.G. SCREENING & SELECTION, LLC in strict conformance with Federal, State EEO laws and Fair Credit Reporting Act (15 U.S.C. Sec. 1681 et seq), 604(b), ("FCRA"), including but not limited to Exhibit A and B (Vermont Residents Only).

8. SUBSCRIBER USE LIMITATIONS - DRIVER'S PRIVACY PROTECTION ACT. Subscriber agrees to use any R.O.G. SCREENING & SELECTION, LLC data, which is the subject of this Agreement, in strict conformance with the Federal Drivers Privacy Protection Act (18 U.S.C. Section 2721 et seq.) and similar state statutes, if applicable.

9. SUBSCRIBER USE LIMITATIONS - GRAMM-LEACH-BLILEY ACT. Subscriber agrees to use any R.O.G. SCREENING & SELECTION, LLC data, which is the subject of this Agreement, in strict conformance with the Gramm-Leach Bliley Act (U.S.C. Title 15, Chapter 94, Section 6801 et seq.) and similar state statutes, if applicable.

10. MVR INFORMATION. If Subscriber is permitted to purchase motor vehicle records (“MVR Data”) from R.O.G. SCREENING & SELECTION, LLC, without in any way limiting Subscriber’s obligations to comply with all state and federal laws governing use of MVR Data, the following specific restrictions apply and are subject to change:

1. Subscriber shall not use any R.O.G. SCREENING & SELECTION, LLC-provided MVR Data, or portions of information contained therein to create or update a file to the end that Subscriber develops its own source of driving history information.
2. As requested by R.O.G. SCREENING & SELECTION, LLC, Subscriber shall complete any state forms that R.O.G. SCREENING & SELECTION, LLC is legally or contractually bound to obtain from Subscriber before serving Subscriber with state MVR Data.
3. R.O.G. SCREENING & SELECTION, LLC (and certain Third Party vendors) may conduct, at their sole cost, reasonable and periodic audits of Subscriber’s use of MVR Data. Subscriber shall maintain for a period of 3 years a complete and accurate record, including identity and purpose, of every access to any personal information in MVR Data in its system. Further, in response to any audit, Subscriber must be able to substantiate the reason for each MVR Data order.

11. MISUSE OF SERVICES OR INFORMATION. Subscriber agrees to take reasonable measures so as to protect against the misuse and/or unauthorized access of R.O.G. SCREENING & SELECTION, LLC’s Services through any methods, including unauthorized access through or to Subscriber’s user identification numbers or passwords (“Account ID’s”). Such misuse or unauthorized access shall include any disclosure, release, viewing or other unauthorized access to information such as social security numbers, driver’s license numbers or dates of birth. Subscriber agrees that R.O.G. SCREENING & SELECTION, LLC may temporarily suspend Subscriber’s access for up to ten (10) business days pending an investigation of Subscriber’s use or access. 12. SUBSCRIBER ACCOUNT MAINTENANCE. Subscriber is responsible for the administration and control of Account ID’s by its employees and third parties, and shall identify a security administrator to coordinate with R.O.G. SCREENING & SELECTION, LLC. Subscriber shall manage all Account ID’s, and notify R.O.G. SCREENING & SELECTION, LLC promptly if any Account ID becomes inactive or invalid. Subscriber shall follow the policies and procedures of R.O.G. SCREENING & SELECTION, LLC with respect to account maintenance as same may be communicated to Subscriber from time to time.

13. SECURITY EVENT. In the event that Subscriber learns or has reason to believe that R.O.G. SCREENING & SELECTION, LLC data has been disclosed or accessed by an unauthorized party, Subscriber will immediately give notice of such event to R.O.G. SCREENING & SELECTION, LLC. Furthermore, in the event that Subscriber has access to or acquires individually identifiable information (e.g., social security numbers, driver’s license numbers or dates of birth) in relation to the Agreement, the following shall apply: Subscriber acknowledges that upon unauthorized acquisition of such individually identifiable information (a “Security Event”), Subscriber shall, in compliance with law, notify the individuals whose information was disclosed that a Security Event has occurred. Also, Subscriber shall be responsible for any other legal obligations which may arise under applicable law in connection with such a Security Event.

14. CHANGES IN USE OR ACCESS. R.O.G. SCREENING & SELECTION, LLC may, at any time, impose restrictions and/or prohibitions on the Subscriber’s use of the Services or certain data. Subscriber understands that such restrictions or changes in access may be the result of a modification in R.O.G. SCREENING & SELECTION, LLC policy, a modification of Third Party agreements, a modification in industry standards, a Security Event or a change in law or regulation. Upon written notification by R.O.G. SCREENING & SELECTION, LLC of such restrictions, Subscriber agrees to comply with such restrictions.

15. PRIVACY. Subscriber shall implement and maintain reasonable security procedures and practices appropriate to the nature of the information it receives from R.O.G. SCREENING & SELECTION, LLC, to protect the personal information from unauthorized access, destruction, use, modification or disclosure.

16. AUDIT. Subscriber understands and agrees that in order to ensure compliance with applicable law and R.O.G. SCREENING & SELECTION, LLC policies, R.O.G. SCREENING & SELECTION, LLC will, at its sole cost, conduct periodic audits of Subscriber activity and may contact Subscriber to provide documentation of executed searches. 18. LIABILITY/WARRANTY. NEITHER R.O.G. SCREENING & SELECTION, LLC NOR THIRD PARTIES SHALL BE LIABLE TO SUBSCRIBER OR TO ANY PERSON CLAIMING THROUGH SUBSCRIBER OR TO WHOM SUBSCRIBER MAY HAVE PROVIDED SERVICE-RELATED INFORMATION FOR ANY LOSS OR INJURY ARISING OUT OF OR CAUSED IN WHOLE OR IN PART BY R.O.G. SCREENING & SELECTION, LLC'S OR THIRD PARTIES' NEGLIGENT ACTS OR OMISSIONS IN PROCURING, COMPILING, COLLECTING, INTERPRETING, REPORTING, COMMUNICATING, OR DELIVERING SERVICES OR IN OTHERWISE PERFORMING THIS AGREEMENT. SUBSCRIBER ACKNOWLEDGES THAT EVERY BUSINESS DECISION INVOLVES ASSUMPTION OF A RISK, AND THAT NEITHER R.O.G. SCREENING & SELECTION, LLC NOR ANY THIRD PARTY UNDERWRITES THAT RISK IN ANY MANNER WHATSOEVER. IF, NOTWITHSTANDING THE FOREGOING, LIABILITY CAN BE IMPOSED ON R.O.G. SCREENING & SELECTION, LLC OR A THIRD PARTY, THEN SUBSCRIBER AGREES THAT R.O.G. SCREENING & SELECTION, LLC'S AND/OR THIRD PARTIES' AGGREGATE LIABILITY FOR ANY AND ALL LOSSES OR INJURIES ARISING OUT OF ANY ACT OR OMISSION OF R.O.G. SCREENING & SELECTION, LLC AND/OR THIRD PARTIES IN CONNECTION WITH ANYTHING TO BE DONE OR FURNISHED UNDER THIS AGREEMENT, REGARDLESS OF THE CAUSE OF THE LOSS OR INJURY (INCLUDING NEGLIGENCE) AND REGARDLESS OF THE NATURE OF THE LEGAL OR EQUITABLE RIGHT CLAIMED TO HAVE BEEN VIOLATED, SHALL NEVER EXCEED THE COST OF THE SERVICE OR SERVICES TO WHICH A GIVEN CLAIM RELATES AND WHICH WAS CHARGED TO SUBSCRIBER, AND SUBSCRIBER COVENANTS AND PROMISES THAT IT WILL NOT SUE R.O.G. SCREENING & SELECTION, LLC AND/OR THIRD PARTIES FOR AN AMOUNT GREATER THAN SUCH SUM EVEN IF R.O.G. SCREENING & SELECTION, LLC AND/OR THIRD PARTIES WERE ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND THAT IT WILL NOT SEEK PUNITIVE DAMAGES IN ANY SUIT AGAINST R.O.G. SCREENING & SELECTION, LLC AND/OR THIRD PARTIES, ALL IN CONSIDERATION OF THE RECEIPT BY SUBSCRIBER OF SERVICES AT THE RATES CHARGED BY R.O.G. SCREENING & SELECTION, LLC AND/OR THIRD PARTIES DO NOT GUARANTEE OR WARRANT THE CORRECTNESS, COMPLETENESS, CURRENTNESS, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE OF THE SERVICES OR THE COMPONENTS THEREOF. IN NO EVENT SHALL R.O.G. SCREENING & SELECTION, LLC OR THIRD PARTIES BE LIABLE FOR ANY DIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES, HOWEVER ARISING, INCURRED BY SUBSCRIBER FROM RECEIPT OR USE OF INFORMATION DELIVERED HEREUNDER, OR THE UNAVAILABILITY THEREOF OTHER THAN ARISING FROM R.O.G. SCREENING & SELECTION, LLC GROSS NEGLIGENCE OR INTENTIONAL MISCONDUCT.

19. INDEMNIFICATION. Subscriber hereby agrees to protect, indemnify, defend and hold harmless R.O.G. SCREENING & SELECTION, LLC and all Third Parties from and against any and all costs, claims, demands, damages, losses and liabilities (including actual attorneys' fees) arising from or in any way related to (i) the use, access or misuse of information by Subscriber (or any third party receiving such information from or through Subscriber), and (ii) Subscriber's breach of any representation, warranty or other provisions of this Agreement. Provisions hereof related to release of claims, indemnification, use of information and Services, payment for Services and disclaimer of warranties shall survive any termination of this Agreement.

20. ASSIGNMENT. This Agreement and the rights and obligations of each party hereto shall not be assigned without the prior written consent of the other party which consent shall not be unreasonably withheld. Consent shall not be required, however, in connection with an assignment to a subsidiary or affiliate of R.O.G. SCREENING & SELECTION, LLC. Upon such assignment: a) RETAIL OPTIMIZATION GROUP, LLC shall promptly advise Subscriber of such transfer; b) the transferee corporation shall expressly agree to assume all obligations hereunder and; c) R.O.G. SCREENING & SELECTION, LLC shall guarantee the performance of the transferee/affiliate's obligations hereunder.

21. AGREEMENT ENTIRETY. This Agreement, as amended, sets forth the entire understanding and agreement between R.O.G. SCREENING & SELECTION, LLC and Subscriber regarding the subject matter herein and supersedes any prior or contemporaneous oral or written agreements or representations, except that access to and use of Third Party services may be governed by terms and conditions different than or in addition to those herein.
